

History

The PCMA (Pharmaceutical Care Management Association) started in 1997 and was affiliated to PCMA in the USA. At the time the founding objectives were focused on Managed Care pharmacy.

As things evolved, it became clear that the common denominator between the stakeholders was healthcare education.

Key individuals saw this as an opportunity to facilitate networking opportunities in a non-partisan, neutral forum connected to the educational CPD (Continuing Professional Development) programme. This in turn focused on clinical topics with an emphasis on evidence-based medicine and the practical aspects of managed healthcare.

By 2001, some of our achievements included the following:

- Hosting sponsored CPD programmes for the benefit of members
- PCMA was introduced to the Western Cape and the launch of a branch in that region
- Nine Special Members (as the Corporate Membership was known back then), comprised of Alcon, AstraZeneca, Eli Lilly, Janssen-Cilag, Lundbeck, Novartis, Pfizer, Pharmacia and Servier

2004

2007

- Monthly CPD's established in Johannesburg, Pretoria and Cape Town
- Five Pharmacoeconomic seminars hosted in Gauteng with significant contribution from **Dr Anban Pillay** (currently Deputy Director General of Health Regulation and Compliance)

Education Programmes

1. Virtual CPD (Continuing Professional Development) Programme:

The CPD programme has been reviewed since the Covid-19 pandemic and as a result, instead of physical meetings, Virtual CPDs (Webinars) are facilitated monthly on the Zoom platform.

Specialists or academics are invited to give a clinical overview of a specific disease or condition. They discuss appropriate drug and / or technological therapeutic care and lifestyle interventions, enabling optimal patient outcomes.

This is a neutral, clinical forum that adheres to a code of conduct that does not allow specific product marketing.

The programme includes:

- Topics that are clinical or of particular interest and relevance
- The opportunity to obtain CPD points
- Meetings that encourage ongoing learning and information sharing
- Opportunity to maintain a portfolio of learning
- Engagement with presenter; specialists / academics
- Opportunity for Standard Members to sponsor one V_CPD per annum and unlimited sponsorship opportunities for Corporate members
